Product description

"B-30 Hi-Noise Single Door Type SM-B30-3HI"

composed of single leafed hinged door with doorblades composed of 0,8 mm steelplates on each side of insulation core of 50 mm mineral wool with density 200 kg/m³, insulation manufactured by Kumgang Korea Chemical Co.Ltd.

The door may be fitted with ventilation grill and kick-out panel (Max. 600 x 800 mm). The doorframe may be welded or bolted to the bulkhead. Total thickness of doorblade 50 mm.

For further details see approved drawing listed below.

Application/Limitations

Approved for use as an integrated part of fire retarding divisions of class B-30. Max. clear door opening: 1000 x 2070 mm (width x height).

The insulation, any surface materials and the pneumatic or electric operation system used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
